We Certify under penalty of perjury that the forgoing is true and correct. We further depose and say that the debit transactions were not originated with fraudulent intent by us or any person acting on our behalf, and that the signature above is my own proper signature.  
The ACH Rules state that electronic entries must be returned within 60 days of the settlement date of the original entry. If the customer requests the form after the 60 day deadline, the customer must settle the claim directly. ACH stop payments require customers to place a stop payment order on a debit at least three banking days prior to the scheduled date of the entry. The Financial Institution will retain the form for one year from the date of the return entry.
